Please note that PennWest California thoroughly examines all financial support documentation submitted by the applicant in support of their application. PennWest California representatives may verify the validity of documentation directly with the sponsor.

A payment plan is available only with approval from the Office of Student Accounts (studentaccounts@pennwest.edu). Late payment is cause for termination of status.
