

### AFFIDAVIT OF FINANCIAL SUPPORT – GRADUATE APPLICANT

Students who are admitted to an undergraduate degree program and intent to become an applicant for an F-1 visa must verify support in the amount of at least \$40,748.80 to obtain Form I-20.

This document must be accompanied by a financial statement in the name of the sponsor. We cannot accept a business or investment account. Acceptable financial support documentation verifying that you possess sufficient funding can be provided in the form of:

- Bank statement(s) from checking or savings. The bank statement must be no more than 6 months old and show 6 months of transactions.
- Official scholarship sponsorship letter verifying amount, source, and dates of award.

Please note that PennWest Clarion thoroughly examines all financial support documentation submitted by the applicant in support of their application. PennWest Clarion representatives may verify the validity of documentation directly with the sponsor.

A payment plan is available only with approval from the Office of Student Accounts ([studentaccounts@pennwest.edu](mailto:studentaccounts@pennwest.edu)). Late payment is cause for termination of status.
